Examples of that type of number include, for individuals, a social security/insurance number, citizen/personal identification/service code/number, and resident registration number.

This form will remain valid unless there is a change in circumstances relating to the Account Holder's tax status or other information included on this form. You must notify us of any change in circumstances that makes the information in this self-certification incorrect or incomplete, and provide an updated self-certification.
